3 Features

Special features of this powerful bass cabinet:

- Inputs: $2 \times \text{lockable NL4 sockets}$, $2 \times 1/4$ " phone sockets
- Power handling: 500 Watt @ 8 Ω
- Cabinet with felt cover and edge protection
- Transport casters



4 Installation and starting up

Unpack and carefully check that there is no transportation damage before using the unit. Keep the equipment packaging. To fully protect the device against vibration, dust and moisture during transportation or storage use the original packaging or your own packaging material suitable for transport or storage, respectively.



NOTICE!

Possible property damage by magnetic fields

Loudspeakers produce a static magnetic field. Therefore, maintain an appropriate distance to devices that can be adversely affected or damaged by an external magnetic field.

Transport castors

The cabinet is equipped with 4 transport casters. The necessary tool for assembly / disassembly is provided.



4.1 Pin assignment


1/4" sockets for signal inputs



Drawing and table indicate the pin assignment of a 1/4" TS phone jack to be used.


1	Signal

The drawing alongside shows the pin assignment of the NL4 inputs (1+/1-).

5 Connections and operating elements





1 INPUT A/B

 $2 \times 1/4$ " phone sockets.

2 INPUT A/B

2 lockable NL4 inputs (1+/1-).

3 HF horn attenuator

Use this control to attenuate the HF horn in a range of **MIN** (HF horn off) and **MAX** (no attenuation of high frequencies).

All four input sockets are wired in parallel.
